The ultimate vision of this effort is to create an ongoing framework for identifying and advancing actions that will enhance community resilience to climate extremes. Based on this convening, a forthcoming report, Regional Community-Level Climate-Related Severe Weather Preparedness and Recovery, will serve to guide future initiatives, ensuring that vulnerable communities are equipped to not only survive but also thrive in the face of escalating climate impacts. Proposed key areas of focus include assessing local resource adequacy, institutional capacity, and the compounding impacts of disparities, as well as addressing gaps in recovery funding. Ongoing efforts, including a consultation with America Is All In network and presentation at NYC Climate Week, will ensure sustained progress in building community resilience to climate extremes.

Brian Moore
